A. 2015 OHA Legislative Positioning – Matrix 1**

Chair Waihe'e recognizes Pou Nui Kāwika Burgess.

Pou Nui Burgess: Aloha Chair and Trustees. At this time, I would like to call on Public Policy Manager Sterling Wong and Senior Public Policy Advocate Jocelyn Doane to provide the legislative updates.

Senior Public Policy Advocate Doane: Aloha Chair and Trustees, our Legislative Matrix update shouldn't take too long and that will allow Sterling to brief you on our Budget Bill. You'll notice that our matrix is getting skinnier, which is exciting and means that session is coming to an end. We have a bunch of new Governor's Messages (GMs), but I first wanted to talk about Item #1 which is Bill 27, Relating to the Minimum Real Property Tax; this is actually a Honolulu City & County measure. It's basically increasing the taxes for all tax exemptions. Currently the tax for a Kuleana tax exemption is \$300 and this bill would raise it to \$1,000; we are recommending OPPOSE. Jim McMahon is down at the County Council today and this is just the first reading so there's much more time to go on this.

You'll notice there are a lot of GMs most of them have already been heard so the positions we take today will most likely not result in testimony. However, I just would like to point out a few.

Item #3, GM636 for Martha Ross to the Crime Victim Compensation Commission - she has substantial experience is social work and has worked with crime victims in the past. Our recommendation is to SUPPORT.

Item #11, GM750 - this is for Suzanne Case as the Chairperson of the Department of Land and Natural Resources. In talking with people, we are recommending SUPPORT and have submitted administrative testimony. There have been some concerns regarding her past in relation to hunting and fencing in particular and she has acknowledged that history. She's shared that what preservation and conservation meant historically for her has changed over time and that things should be looked at on a case-by-case basis. We hope to work with her on any concerns our beneficiaries should have related to hunting and so forth. She also has publicly supported community-based management, so we feel it's a good idea to support her.

Item #20, GM820 - this is for William Balfour, Jr. to the Commission on Water Resource Management. Denise Antolini was asked to stay on until the end of June. We feel her legal experience in particular would help the commission make decisions more consistent with the law. We are recommending COMMENT for Mr. Balfour.

For Items #22, 23, & 24 – GM833 Hulu Lindsey for Kaho'olawe Island Reserve Commission, and both GM837 & 838 Wayne Tanaka for the Kane'ohe Bay Regional Council are both OHA seats that Chair Lindsey and Ka Pouhana nominated. So our recommendation is to SUPPORT of course.

Item #25 - GM868 Jonathan Scheuer for the Land Use Commission, clearly he has substantial experience with our community, with land use, and land management, so we are recommending SUPPORT.

Senior Public Policy Advocate Doane: None of the bills that we OPPOSE are still alive, so that concludes are large matrix update for this week.

Trustee Apo moves to approve Administration's recommendations on *NEW BILLS* (1 - 27) and *BILL POSITIONS FOR RECONSIDERATION* (28 - 32), on the OHA Legislative Positioning Matrix dated April 22, 2015, as amended.

V. UNFINISHED BUSINESS

A. 2015 OHA Legislative Package Updates – Matrix 2**

Public Policy Manager Wong: Aloha Chair, Vice-Chair and Members of the Committee. I'll go quickly over our OHA package which is actually doing really well, I'll save the budget bill for last.

OHA-2 - Relating to the Hawaiian Language Immersion Program. There is a vehicle moving right now and it's in Conference. There's a good chance some version of this bill will come out, unfortunately the money might come out. Even if the appropriation comes out, the reporting requirements are still really important and very beneficial to have.

OHA-3 - Relating to Training, as you know this bill has always made it to conference every year.

OHA-4 - Relating to Agriculture, this was enrolled to the Governor already. We really would like to thank Deja Ostrowski as she did a great job working on this bill. The House agreed to the Senate draft and it has been enrolled to the Governor. He has 10 days to sign it into law or else it becomes law without his signature unless he vetoes it.

OHA-5 - Relating to Hawaiian Plants, we've been talking a lot with the Committee Chairs on this one. We might make a slight amendment in Conference, but we're really optimistic about this bill getting through SB435.

OHA-6 - Relating to Incarcerated Parents, the Pa'ahao Bill has already been enrolled to the Governor. He has until Friday to sign or veto it or it will automatically become law.

OHA-7 - Unfortunately our PLT Resolution died, but given everything else, we'll take the resolution dying and move forward with the rest of our package. We still achieved our goal of educating legislators with this resolution.

A bill that's not in our package this year, but was last year, the Remnants Bill, is also in Conference. The Senate draft is something we're willing to live with as it's an improvement on what we have now. It prohibits the BLNR from selling a remnant outside of the Act 176 process. If they make a finding that the property has natural and cultural resources that impact our beneficiaries' practices and if there are accesses, then such a parcel with these attributes on it and with the BLNR making a finding that those things are on it, will then prohibit the BLNR from selling said parcel outside of the legislative process.

OHA-1 Budget Bill; this year we requested three new budget provisos for *Health, Housing,* and *Income* and what the WAM Committee did was instead of giving us those three it gave us a new proviso for \$500,000 dollars. In talking to WAM Staff, the idea there was they couldn't give us everything we wanted, but they didn't want to specify which provisos we could spend the money on. So of the six (6) provisos we had this year, the three historical ones for *Education, Social Services,* and *Legal Services* are still in our budget and remain whole; so they're exactly what we got in years past. For the three new provisos, they took them out and gave us \$500,000 to use at our discretion.

Trustee Akana: So what did we end up in TOTAL for our budget?

Public Policy Manager Wong: Totally speaking, if you look at our biennium budget from last year, it's across the biennium \$100,000 less. However, it's important to keep in mind that our biennium budget the past two years was an increase from the previous year, so we're ballpark about the same.

Trustee Apoliona: Remind me, what would the total have been if we were successful?

Senior Public Policy Advocate Doane: The total that we were asking for was 5.8 million dollars over two years, so that would be 2.9 million dollars a year.

Public Policy Manager Wong: They added a new Section 9 to the bill; there are a number of things that it requires which affects all of the provisos. It makes clear that the appropriations are spent at the discretion of the Board of Trustees and that no State general funds should be expended unless matched by the expenditure of at least an equal amount of OHA trust funds.

We have concerns with Item 3 in the bill which reads "All State general funds appropriated for beneficiary advocacy (the programmatic funds) shall be expended only for the direct support of beneficiaries". There are a lot of ways to interpret "direct support". One of the most conservative ways to interpret it would be a direct-cash payment to beneficiaries which is neither what we want nor what we do. There's also the concern that some of our grantees in our contracts get monies and they're used to pay for actual positions that then provide the services. This language would be very limiting and problematic so we've asked them to consider removing it from the bill.

Our budget bill will hopefully be heard on April 30 and May 1, and the legislators do like to see the Trustees and CEO there when they pass it out of conference. So we will update you as the date nears and hopefully some of you can make it. That's all we have for today.
